



## LifeVantage Privacy Policy and Website Use Agreement

Thank you for visiting our website (“Site”). As used herein, the terms “LifeVantage”, “our,” “we,” and “us” mean LifeVantage Corporation and/or its subsidiaries. We will update the LifeVantage Privacy Policy and Website Use Agreement (“Policy” or “Agreement”) from time to time without prior notice and encourage you to review this Policy periodically for any updates.

***YOUR USE OF OUR SITE CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS POLICY. PLEASE READ THEM CAREFULLY BEFORE USING THE SITE. IF YOU DO NOT AGREE WITH ANY PART OF THESE TERMS, YOU MUST NOT USE OUR SITE. IF YOU ARE A CUSTOMER AND/OR DISTRIBUTOR, YOU ARE BOUND BY ADDITIONAL TERMS AND CONDITIONS CONTAINED IN YOUR [LIFEVANTAGE CUSTOMER AGREEMENT](#) AND/OR [LIFEVANTAGE DISTRIBUTOR APPLICATION AND AGREEMENT](#), [LIFEVANTAGE POLICIES AND PROCEDURES](#), [LIFEVANTAGE COMPENSATION PLAN](#) AND ANY OTHER AGREEMENT YOU HAVE ENTERED INTO WITH US.***

We will communicate with you by e-mail or by posting notices on this Site. You agree that all agreements, notices, disclosures, or other communications that we provide to you electronically satisfy any legal requirement that such communications be in writing.

You are granted a limited, nonexclusive, nontransferable license to access the Site and its content in accordance with this Policy. By accessing this Site and becoming a User, you certify that you are 18 years of age or older. If you are under the age 18, you may use our Site only with the involvement of a parent or guardian who has agreed to be bound by this Policy.

Our Site is hosted in the United States of America (“USA”) and contains information that is appropriate for access and use in the USA. While we provide specific information for LifeVantage Authorized Country markets, we make no representation that any materials on the Site are appropriate or available for use outside the USA or those designated LifeVantage Authorized Country markets. Any references on the Site to specific products or services are applicable only to those available in the USA and/or other authorized LifeVantage country markets. Any who access this Site from locations outside the USA do so according to their own initiative and are responsible for compliance with local laws.

We reserve the right to refuse service in our sole discretion and without notice. You are solely responsible for your use of the Site, and you agree to compensate, hold harmless, and defend us from any claims, damages, losses, liabilities, costs, and expenses, including attorneys’ fees, resulting from your use or misuse of the Site. Posting or transmitting any unlawful, infringing, threatening, libelous, defamatory, obscene, indecent, inflammatory, pornographic or profane material or any material that could constitute or encourage conduct that would be considered a criminal offense, give rise to civil liability, or otherwise violate any law, is strictly prohibited.

LifeVantage is committed to safeguarding and protecting its users, distributors and customers and this Policy informs you about the types of information we may collect about you when you visit our Site and how we may use that information.

LifeVantage collects either anonymous (“General Information”) or Personal Information on the Site. General Information refers to website use information that cannot be traced back to a specific individual, e.g., the total number of visitors to our Site. Personal information refers to specific information about a Site user, e.g., name, address, e-mail address, telephone number and credit card information. Please note that it is your choice whether to share Personal Information via the Site.

Certain General Information is automatically collected including “site usage” information from all Site users only in the aggregate. General Information helps LifeVantage to improve your experience and may be shared with third parties any time.

When you place an order for products or services, we collect Personal Information (such as name, contact and billing information, credit card, and other transaction information) and we use this information to deliver your order, process payment, and to communicate with you about the status of your order. We will provide information necessary to the delivery of your order to our shipping partners to include the type of products ordered.

All billing and other information submitted to this Site must be truthful and accurate. Providing any untruthful or inaccurate information is a breach of this Agreement and may also be a breach of any applicable [LifeVantage Customer Agreement](#) and/or [LifeVantage Distributor Application and Agreement](#). By completing the checkout process you agree to accept and to pay for the product(s) or service(s) requested. You represent and warrant that you have the legal right to use any credit card or other payment means used to complete any transaction.

In the event a product is listed at an incorrect price or with incorrect information due to typographical error or error in pricing or product information, LifeVantage shall have the right to refuse or cancel any orders placed for any product listed at the incorrect price. LifeVantage shall have the right to refuse or cancel any such orders whether the order has been confirmed or not and the User’s credit card charged. LifeVantage reserves the right in its sole discretion to refuse or cancel any order for any reason. If your credit card has already been charged for the purchase and your order is cancelled, LifeVantage shall immediately issue a credit to your credit card account in the amount of the charge. LifeVantage attempts to be accurate in all product descriptions, nevertheless, LifeVantage does not warrant that any product description or the content on the Site is accurate, complete, reliable, current or error free. If you find the product is not as described, your sole remedy is to return it pursuant to LifeVantage’s return policy.

LifeVantage reserves the right, without prior notice, (a) to impose conditions on the honoring of any coupon, coupon code, promotional code or other promotion, (b) change a product description, (c) limit the availability of any product or services, (d) refuse to provide any Site user, distributor or customer with any services. We utilize Secure Sockets Layer (“SSL”) for our website security. SSL creates an encrypted link between the web server and the web browser to ensure that the data passed between the web server and the browser remains private and secure.

Credit card information collected at registration or for shopping cart orders is used only to

process payment for the transaction and, generally, is not retained on our Site. You may, however, voluntarily elect to securely store personal credit card information for use in future orders on your web browser. You may add, edit, and delete your stored card information at any time.

Except as disclosed in this Policy, we do not sell, trade, rent, or otherwise retransmit any Personal Information we collect online unless we have your permission. Any Personal Information you provide to us will be stored in our US databases or with our third-party vendor who processes our credit card transactions in the United States of America. LifeVantage may disclose certain information to third-party vendors, if necessary, to provide you with your requested product or service and to third parties who provide various services to LifeVantage all of which must adhere to this Policy.

To assure the highest level of personal service to our distributors and customers, we may share Personal Information about you (excluding credit card information and order details) with your servicing distributor who is also bound by this Policy.

We will provide required Personal Information in response to a lawful court order, subpoena, or government investigation. We also reserve the right to report to law enforcement agencies any activities that we in good faith believe to be unlawful. We may release Personal Information when we believe that such release is reasonably necessary to enforce contracts and/or agreements or to protect the rights, property, and safety of others and ourselves.

We acknowledge your trust and are committed to take reasonable steps to protect Personal Information you provide online from loss, misuse, and unauthorized access. We employ physical, electronic, and managerial processes to safeguard and secure your information. Our Site makes use of a “cookie”, which is a small data file transferred to your computer’s hard drive that allows a Web site to respond to you by gathering and remembering information about your preferences in order to tailor the Site’s operation to your needs and desires. Cookies also enable us to keep track of a consumer’s electronic “shopping cart” before completing a purchase. Accepting a cookie does not provide us access to your computer or any Personal Information about you, other than the information you choose to share. Other servers cannot read them, nor can they be used to deliver a virus.

We use cookies for the following purposes: Essential Cookies are used to allow users to stay logged in and for storing shopping cart Identification and contents. In Countries where allowed, analytics cookies are used with Google Analytics to gather data on the number of people accessing our site, where they are accessing from, what pages they visit, and what technology they are using. Google Analytics cannot identify you personally but does allow us to understand our users as a group, for example by recording what browsers are being used. Analytics cookies may either be first party cookies or third-party cookies as follows:

- \_utma has typical content of randomly generated numbers that expire after two years;
- \_utmb has typical content of randomly generated numbers that expire after 30 minutes;
- \_utmc has typical content of randomly generated numbers that expire upon user existing the browser;
- \_utmz has typical content of randomly generated numbers and information about how the page or site was reached, e.g., directly or via a link, organic search or paid search that expire after six months; and
- \_\_utmmobile has typical content of randomly generated numbers that expire after two

years.
